Call for abstracts

The 28th Annual Conference on

Environmental Economics, Policy and International Environmental Relations

Prague University of Economics and Business

27 November 2026

This conference provides an ideal setting for the comprehensive exchange of ideas and discussion of new theoretical and empirical research papers in environmental economics and policy. We welcome papers based on novel quantitative and econometric techniques, as well as those applying qualitative research methods. Papers that explicitly outline policy implications are particularly encouraged. We invite doctoral students and postdoctoral researchers to submit papers.

These key-issues are of particular interest of the conference:

- Economic modelling of climate change and energy policies,
- Behavioral economics and preference heterogeneity for environmental goods,
- International and domestic climate policies and related institutions
- Socio-economic impacts of climate change on tourism-dependent regions,
- Environmental investment and sustainable finance,
- International environmental relations, including environmental aspects of international trade,
- Market and non-market valuation of environmental goods and services.

Format of the conference

At the conference, presentations will be made in standard sessions (15–20 minutes for the presentation and 10 minutes for the discussion) and egg-timer sessions (5–7 minutes for the presentation and 3 minutes for the discussion). The Scientific Committee will select papers based on **abstracts of 300–500 words**. Authors must structure their abstract as follows: (1) an overview and the topic and the research goal(s); (2) the research methods and the data; (3) the preliminary results; and (4) the policy implications and conclusion. The conference is free of charge. Participants make their own travel and accommodation arrangements.
